


# Stock & Bond Correlations Climbing

When stocks perform poorly, having no correlation or even negative correlation between stocks and bonds can be a good thing. However, when stocks and bonds both perform poorly and the correlation is positive (as it was in 2022), it can lead to unsatisfactory results. With the high level of stock and bond correlation experienced over the past few years there is a reduced amount of diversification benefit between stocks and bonds in traditional portfolios.

**Bloomberg®** US Aggregate Bond Index – A broad-based flagship benchmark that measures the investment grade, US dollar-denominated, fixed-rate taxable bond market.
